Thanks to all of the members who volunteered during 2016. We want all of our membership to participate by joining a committee or volunteering for a work day or plan an event for all of us to enjoy.

We want to increase the diversity for the board and all of our committees. The current board and committee members are male dominated. I invite our female members to become involved. We also need younger representatives and volunteers for all activities.

2016 activities included: Water quality monitoring; installing fish sticks; planting trout in Logan Creek; phragmites treatment; power loading sign and moving of rocks at boat ramp; an all member e-mail policy; propane co-op; liaison with Ridges ; canoe/kayak dock at the Ridges Logan Creek property; annual picnic and fall dinner; installation, recovery and maintenance of buoys and signs; flow obstructing debris clearance from Whitefish Bay Creek; and dam monitoring and coordination with Sevastopol for water levels.

2017 will continue our routine activities in addition to: update of the website ; bulrush density survey; review and update of member education and brochures ; expanding invasive concerns to include the stony starwort; improving fish habitat; publishing the biennial directory; continued clearing of the creek; and a proposal to restart the lake wide garage sale.

I hope everyone has another wonderful year.

### Keeping up to date with the CLAA Community and Clark Lake area

Part of our mission is to engender a sense of community and that includes sharing information with all of you. Direct mailings to the entire membership are costly so we typically do them once a year for the membership renewal and this annual update.

The website (<u>http://www.clarklakewi.com</u>) is a notice board and repository of past information. Members receive e-mail notices when new information is posted. The current webmaster is stepping down so we need a webmaster volunteer.

We are sensitive to the volume of e-mails that can flood your inbox. Notices from us include our name in the mail title. The notices are currently coming from a g-mail account but will return to web based, secure e-mail when the update occurs in April.

Our website has a link to both the Jacksonport and Sevastopol town websites. At these sites simply use the "Subscribe to updates" or "Subscribe to notices" option if you wish to receive notice of town meetings and agendas. Remember both the Pulse and Advocate have electronic editions for further news.

Another link that is on the website is the Wisconsin Lakes Association. CLAA is a member and this group does advocacy for lake owners. This includes information about and tracking of various legislative actions in addition to educational articles.

Each director is assigned a set of members to whom they are responsible. Your board representative should try to have a face to face with you at least twice a year as they deliver the flyers for the annual meeting and the fall dinner and this year the directory. They are also willing to receive calls; e-mails or visits should you have comments or concerns.

#### **Financial/Annual dues**

Our budgeted income was about equal to our fixed budgeted expenses. We had been funding our special projects from our cash reserves. The \$5 dues increase allows income to offset both the regular fixed expenses and special projects without delving into the reserve funds. We have been happy to receive some higher than expected donations in the last year and special contributions for the Logan Creek trout. Our special project cost last year, the fish sticks, were offset by a grant so we actually were able to protect the cash reserves and have a current healthy balance of \$9400.
