CLARK LAKE ADVANCEMENT ASSOCIATION SPRING/SUMMER, 2011

Our Clark Lake Advancement Association (CLAA) has a special anniversary – we just turned 50 years old – stay tuned for special events celebrating this important milestone. When I started this letter in late February, we were in the midst of another classic winter, with lake ice more than 2 feet thick, and ice fishermen driving all over the lake. As evidence that spring is indeed here, we had full ice-out on April 11 – the latest ice-out in a long time. Lake level is normal for this time of year. We have much to report on, so here we go.

2011 MEETINGS & EVENTS:

BOARD OF DIRECTOR MEETINGS

Directors will meet at the Jacksonport Town Hall on May 7, June 4 (at Whitefish Dunes State Park conference room), July 9 (8 AM), August 13, and September 17 to conduct lake business. Meetings start promptly a 9 AM, and are open to all members.

ANNUAL MEETING

Our Annual Meeting is scheduled for **July 9 at 9 AM** at the Jacksonport Town Hall. Agenda items for the Annual Meeting include a report from the Door County Zoning Department on their efforts to update the Door County shoreland zoning rules in accordance with NR115. DNR folks will review the recently enacted pier rules and more. We will also elect several lake directors. Please join us.

CLARK LAKE PICNIC

The picnic will be on **July 23 at the Jacksonport Lakeside Park**, with fun starting at 11 AM and food served at noon. More details later.

GOLF OUTING & FALL DINNER

The annual golf outing is scheduled for **September 5**, with the fall dinner scheduled for **September 17**. We are also scheduling a lake-wide rummage sale weekend – stay tuned for more details. Please join us at as many events as you can.

INVASIVE SPECIES:

We know that Zebra mussels are in Clark Lake. We also have an invasive plant (phragmites) expanding its range along the far northeast shore and along the north shore of East Bay. For the third year, a work party in late-September 2010 worked to control this invasive plant. We will likely attack these plants again during the fall of 2011. With even more invasive species in

Lake Michigan and Green Bay, it is important that we clean and drain our boats prior to launching and upon removal from the lake. Equally important is that the Town of Sevastopol maintain the fish screens in place at the dam to prevent invasive fish, such as the Asian Carp (forthcoming) and fish with VHS virus from destroying our Clark Lake fishery. We will continue to stress the importance of proper placement of these screens with the Town. This topic remains a top priority for your board.

Wisconsin NR40 identifies invasive species and prohibits introduction into Wisconsin. Act 55 prohibits the transport of invasive species on or in boats leaving lakes or just traveling down the highway. Enforcement officials can stop vehicles when there is reason to believe that invasive species are on or in boats. Water tanks and live-wells must be emptied on shore before launching because water in these tanks can hold invasive species.

CLARK LAKE DAM & BOAT RAMPS:

The Town of Sevastopol added security fences around the dam last year and is adding "No Trespass" signs around the dam to prevent access to the dam. The town is also in the process of obtaining state approval for adding signage and barriers to prevent boats from entering the inlet channel to the dam. We are monitoring this effort and may engage in the DNR approval process. The Town of Sevastopol in an effort to protect the concrete on the west side boat ramp closed off this access point for winter use. We understand they did this without prior DNR notice and approval, and are now responding to DNR letters and inquiries. The ramp is back in service. The Town of Jacksonport was granted a permit from the DNR to repair the east side boat ramp and will likely perform the repairs sometime this year.

SWIM BEACH TESTING:

2010 marked the fifth consecutive year that water samples were collected weekly during summer the at our Clark Lake public beach for e. coli bacterial analysis. All samples were below the level for concern and were well below the beach closure level.
