## **CLARK LAKE ADVANCEMENT ASSOCIATION WINTER/SPRING, 2013**

Wow – a classic Door County winter, with the lake well frozen, with cross county skiers and snowmobiles enjoying the deep snow and fishermen using the lake. This year, we're publishing a winter/spring newsletter and a summer/fall newsletter to keep folks up to speed on lake activities.

### **2013 MEETINGS & EVENTS:**

Director meetings are at the Jacksonport Town Hall on May 4, June 1, July 6 (8am), August 10, and September 28 to conduct lake business. Unless otherwise noted, meetings start promptly at 9AM, and are open to members. Our **Annual Meeting** is scheduled for **July 6 at 9AM** at the Jacksonport Town Hall. Agenda items for the Annual Meeting include a presentation by Steve Leonard, Ridges Sanctuary and election of several lake directors. The **picnic** will be on **July 20 at the Jacksonport Lakeside Park**, with fun starting at 11AM, and food served at noon. Check the website for details. The annual golf outing is tentatively scheduled for August 17, with the fall dinner scheduled for September 14. On September 7 we will be holding our sixth consecutive "Phragmites Fest". We are also planning another lake-wide rummage sale weekend – if we can find two volunteers to organize it. Please join us at as many events as you can.

### **VOLUNTEER HELP:**

Our lake association is successful because of the care and interest of volunteers in maintaining and improving conditions on Clark Lake. Your CLAA board can't do it alone – we need additional volunteers to help on 2012 lake activities, such as the rummage sale, goose control, picnic and phragmites control.

### **INVASIVE SPECIES:**

We continue to battle the invasive plant (Phragmites) along the far northeast shore and along the north and west shores of East Bay. A work party in early September 2012 made good progress towards controlling this invasive plant – our work party is scheduled for September 7<sup>th</sup> this year – please help us in this effort. To prevent bringing more aquatic invasive species (AIS) into Clark Lake, or moving AIS from Clark Lake into other lakes, please remember to clean and drain your boat prior to launching into and upon removal from the lake. It is also crucial that the Town of Sevastopol maintains screens and bar racks in place at the dam to prevent invasive fish from getting into Clark Lake. We will continue to stress the importance of proper placement of these screens with the Town.

### **CLARK LAKE DAM & BOAT RAMPS:**

The Town of Sevastopol, with financial support from Jacksonport and a \$2000 CLAA contribution is replacing the west side boat ramp with a concrete ramp. **Please see the website for updates – the latest schedule shows the new ramp being installed in mid-May. This work will necessitate taking the ramp out of service for perhaps 5-7 days.**

### **SWIM BEACH TESTING:**

Water samples were collected weekly during summer at the Clark Lake public beach for E. coli bacterial analysis. 2012 results were within guidelines, improved over 2011.

### **GOOSE CONTROL:**


At the 2012 Annual Meeting, CLAA voted to control the goose population on Clark Lake. High population levels are impacting our bulrush population, and contribute to higher than normal E-coli levels at the swim beach. Geese also impact lawns, docks and rafts around the lake. CLAA received a permit to oil goose eggs this spring. We will oil the eggs in a number of nests around the lake, which should help control the goose population. **Please see the volunteer tab on the website, to help us.**

### **LAKE HISTORY:**

We're making progress on collecting historic photographs and other history of Clark Lake. Please forward any pictures, stories and other historical memorabilia regarding early days on Clark Lake to Kirby (kbouthilet@yahoo.com) for possible posting on our website. During 2013, Mike O'Brien (CLAA Director) will be interviewing people around the lake to document previous times on the lake.

Further back, how long has Clark Lake been a lake vs. a bay of Lake Michigan?

To help answer that question, over the past three years, faculty from the University of Wisconsin-Platteville, the University of Nebraska Lincoln and the Wisconsin State Geologic and Natural History Survey have worked on a National Science Foundation (NSF) sponsored project to study dunes and other shoreline features in Door County. This project was part of NSF's Research Experience for Undergraduates program and included training students in earth science techniques. Students worked in Whitefish Dunes State Park to study how the Dunes and lake sediments that isolate Clark Lake formed over the past several thousand years. See the following figure for sample locations and the age of the dunes. Based on these results, the barrier that separates Clark Lake from Lake Michigan formed about 4.4 to 5.4 thousand years ago during a time known as the Nipissing Phase of Lake Michigan. Most of the large dunes that characterize the state park formed rapidly after that, although some of them were active until as recently as 1000 years ago. There are older shorelines that parallel the western shore of Clark Lake that Dr. Rawlings (UW-Platteville) hopes to study in the future.

### **WALLEYE POPULATION:**

Don Hinnenthal and several CLAA board members are talking with DNR fisheries staff and the Walleyes for Tomorrow organization about the walleye population in Clark Lake, and how best to enhance what appears to be a declining population of adult walleyes. The best approach to enhance spawning success appears to be adding a layer of small rocks to select existing walleye spawning reefs around the lake. Our plan includes identifying existing spawning reefs this spring, developing a plan to add rocks to these reefs, obtaining DNR approval, and seeking funds from Walleyes for Tomorrow to purchase the rocks. **Finally, we will be looking for volunteers next winter to place the rocks on the reefs.** The other, complementary approach towards improving the walleye population involves using a voluntary catch and release approach for large, adult walleyes. Please consider taking the small and large mouth bass home for eating vs. walleyes.

### **FORMATION OF A CO-OP FOR CLARK LAKE RESIDENTS:**

The CLAA continues its efforts towards “Cooperative Purchasing”. This consists of the consolidation of similar individual purchases into a larger group purchase to achieve greater value at significantly reduced prices. The first application of the co-op is targeted towards the purchase of propane.
