Dear Landowner.

The purpose of this letter is to inform you of an opportunity to learn more about potential invasive species on your property. The Door County Invasive Species Team (DCIST) and Door County Soil & Water Conservation Department (SWCD) has received a Great Lakes Restoration Initiative grant to inventory and control purple loosestrife, non-native bittersweet vine, and European marsh thistle within areas that have high ecological importance and are easily invaded by these species. Your property has been identified as one of these areas and we would like to work with you to identify and control these potential invaders.

How was my property identified?

DCIST has been working with UW-Madison to identify areas that are highly susceptible to specific invasive species using public data such as road right of ways, previously recorded invasive species populations, habitat types, etc. and combined this data with Door County's Green Print Goal: Protect Habitat for Native Plants and Animals data to create a new data set. The Door County Green Print Initiative was a collaborative effort comprised of various federal, state, & county agencies, various local non-profits, and the University of Wisconsin. The UW-Madison susceptibility models paired with the Door County's Green Print Initiative data allows DCIST to create a targeted approach for invasive species efforts and help to maintain Door County's natural areas.
