## **Committee and Work Group Reports**

## **Social Committee (Richard Martin)**

We had a great July 4th boat parade with Jerry Voelker's band and an almost dry bike ride around the lake.

There are only three events currently scheduled in 2021: Annual meeting with refreshments (7/10/21), Boat Parade with Jerry Voelker's band (74/21) – Rain date 7/3 – Saturday (without a band), a Youth Event (TBA), and the Fall Dinner (9/11/21) at the Log Den. If anyone has comments/concerns please contact one of the board members.

## Water Quality/Vegetation Control Committee (Mark Weisse)

In 2020 we planted examples of native plants and soft bioengineering at the west side boat launch. Thank you to the many volunteers who helped plan, install the plants and bushes, water and weed for this project. We will need volunteers again this year for continued maintenance starting this spring.

70% responded in our survey that they did not have a 35-foot vegetation buffer. Shoreline damage has also resulted in over a dozen new rip rap installations. Bioengineered products may be appropriate instead of rip rap in some low energy locations. A 35-ft vegetation buffer and use of native plants is recommended with rip rap. View the native plants and coir logs at the demonstration plot.

Phragmites continues to require our attention. Watch for CLAA announcements calling for volunteers. There will be non-chemical workdays in the Spring and the usual herbicide treatment in the Fall.

Boating traffic increased 75% compared to 2019. COVID eliminated our ramp volunteer presence. We plan re-starting trailer inspection and boater education in 2021. This is an opportunity for all ages (and families) to contribute to protecting Clark Lake, so please consider volunteering.

Trenching from propellers is visible around the lake. Avoid towing and high-speed boating in water levels less than four feet. A map highlighting the four foot depth is now posted.

There was no E. coli contamination, but bacterial monitoring in local well water testing programs did reveal coliform contamination between 15 and 25%. UW-Oshkosh plans more well water testing studies in 2021 and 2022. Watch for notices and be sure to sign up.

## Fish/Wildlife Committee (Pat Canney)

The fisheries committee completed the largest fishsticks on Clark Lake near the duck blind point (South end of Clark Lake Drive) on 2/20/21. Volunteers were Dick Martin (and his 4 wheeler), Mike Brunet, Mark Weisse, and Pat Canney. Dan Ewaskowitz provided logging equipment and placing of the trees. Our fish sticks permit runs thru 2022 and hopefully with the addition of extra sites we will return to the ice next winter to continue the work.

The DNR completed the fish sampling survey (Spring and Fall 2019) to get a firsthand look at the fish populations on the lake. The Report has not been completed. We will keep you updated as we have more information.

Ice fishing traffic was heavy due to the ice quality on the Bay and the short season this winter.

## Safety/ Lake Maintenance (Bob Defaut & Chuck Birringer)

Each year, volunteers will be needed to install and remove the lake buoys and the Ridges dock. Since these tasks typically require calm wind conditions, volunteers must be available on demand in May and again in October. While good internet options appear to be at a premium in rural Door County there are three options that provide adequate service to some of our members.

- 1) The Broadband Tower located next to the West Shore Boat Launch is now operational. DC Broadband requires a line of sight with the tower to obtain best reception. Please contact DC Broadband to determine if you can receive their service, what packages they offer and their internet speeds
- 2) AT&T Internet has been able to provide service in certain areas but not all areas around Clark Lake. Please contact AT&T to determine if you can receive their service, what packages they offer and their internet speeds.
- 3) Starlink Satellite Internet has been very promising for the members that it serves. While download and upload are exceptional, there is a periodic loss of connection when it appears to switch from one satellite to another. Starlink is still in Beta because all the satellites have still not been launched. Starlink does not provide their own installation.

## Treasurer's Report and Annual Dues (Sue Oldenburg)

Paid membership end of 2020 was 230 compared to 240 in 2019.

End of 2020 numbers were: Cash balance of \$29,598.05; Designated for projects \$7,419.66; Undesignated funds \$18,931.68 Member donations \$1,585 (includes \$400 restricted); and total disbursements for 2020 were \$7,962.49, under budget of \$3,892.51.

Entering 2020, the CLAA is in a very sound financial condition, which favorably positions the organization to fulfill its stated mission of protecting and enhancing the enjoyment of Clark Lake.
