## **President's Message**

2021 was a similar to 2020 due to COVID-19 and Health Department restrictions. ## **Committee and Work Group Reports**

#### **Social Committee (Richard Martin)**

We had another great July 4th boat parade with Jerry Voelker's band and great Fall Dinner at the Log Den.

There are only three events currently scheduled in 2022: Annual meeting with refreshments (7/9/22), Boat Parade with Jerry Voelker's band (7/3/22) – No rain date, Youth Event with a parent (TBA), and the Fall Dinner (TBD). If anyone has comments/concerns please contact one of the board members.

#### Water Quality/Vegetation Control Committee (Mark Weisse)

Native plants along your shore are essential to maintaining water quality and habitat. Visit the west side ramp to see some examples of native plants and soft bioengineering. Taking that first step can be hard so we formed a group, Buffer Buddies, to support and encourage each other to begin limited native plant projects. Contact us to join and share resources, supplies and encouragement.

Aquatic invasive species control efforts for phragmites, purple loosestrife and thistles was coordinated in 2021 with the Door County Invasive Species Team (DCIST). Watch for volunteer opportunities later in the summer. Educational material will be e-mailed on a periodic basis using the new WQVC group mailing app.

Boating traffic continued at high levels in 2021. Avoid towing and high-speed boating in water less than four feet deep as indicated on maps at each ramp. As always, stay out of any bulrush bed and remind visitors of the no motor and no wake zones. We did not have any Ramp Volunteers last summer but please consider assisting this year. This is an opportunity for all ages (and families) to contribute to protecting Clark Lake.

This spring UW-Oshkosh is doing another all county well water sampling. WQVC is tracking the results for the Clark Lake watershed and maps will be available at our website. We are looking for volunteers to facilitate more sampling throughout the watershed.

The Wisconsin Citizen Lake Monitoring program numbers continue to look good. This year, because of the thickness of growth at the mouth of Logan Creek, we also did nutrient and plant sampling along Logan Creek. There were no new findings we must all do our part and follow the guidelines for responsible stewardship set forth on the website.

#### Fish/Wildlife Committee (Bob Fox)

The fisheries committee completed repair of the largest fish sticks on Clark Lake near the duck blind point (South end of Clark Lake Drive) in August 2021. Volunteers were Dick Martin, Bob Fox, Mark Weisse, and Pat Canney (more?). We have nothing planned for this year. Our fish sticks permit runs thru 2022 and hopefully with the addition of extra sites we will return to the ice next winter to continue the work.

The DNR completed the fish sampling survey (Spring and Fall 2019) to get a firsthand look at the fish populations on the lake. The Report has not been completed. We will keep you updated as we have more information.

Ice fishing traffic may be heavy due to the ice quality on the Bay and the short season this winter.

## Safety & Lake Maintenance Committee (Bob Defaut & Chuck Birringer)

This year we are again looking for volunteers in the Spring and/or fall to assist with the lake buoys and the Ridges Dock. Thank you to Kathy Steinmetz for her quick thinking that enabled CLAA to obtain several new buoys at no charge that had been marked as scrap. This saved CLAA over \$1,000.

The Board has approved adding yellow striping on the northern portion of the West Shore Boat Launch In an attempt to deter people from parking on that side of the Boat Launch. In addition to the yellow striping, 100-foot white lines will be painted on either side of the Launching Approach as a guide to assist boaters when launching their boats.

## **Communications Committee (Chuck Birringer)**

In a response to several emails from the membership, two new sections were added to the Home Page: 1) "Health and Safety Alerts" and 2) "What is Happening on Clark Lake".

The first section will provide updates for questions on Health/Safety Concerns such as swimmers itch, lake e-coli levels, dangerous situations on the lake, etc. The second section will provide upcoming events or Activities on the Home Page which should make that information easier to access that having to dig deeper into the website to find them.

Another area of concern for members is that they are not receiving emails from the Association Website News/Notices. The Communications Committee will work with the CLAA Webmaster to resolve this problem.

We are looking for someone that would coordinate the Planning and Production of an Association Newsletter(s). Please contact Chuck Birringer if you are interested.

The Annual Letter and Membership and Dues Form is being mailed out to the membership in early February coincide with the calendar year. Changes to your Membership Information can be made by updating the Membership Form and mailing it with your dues. Changes and dues payment can also now be made online on the CLAA Website under the Members Menu Join Today Tab.

The Directory is only published every other year, so there will not be one published this year. The online directory, which is updated periodically is available on the website under the Member Menu – Member Directory Tab.

We have submitted letters of support addressing Short Term Rentals (STR), while focusing on following Good Neighbor Best Practices. We have also responded to a health concern concerning people taking their horses swimming in Clark Lake and not picking up after their horses and several families whose members have contracted "Swimmers Itch".

## Website Work Group (Chuck Birringer)

## **Cooperative Purchasing Work Group (Chuck Birringer)**

We will continue with the Propane and Garbage/Recycling/Asphalt Sealcoating Purchasing Agreements in 2022. Don't forget April 1, 2022 is the deadline for dues if you want to participate in this year's propane contract.

## Internet

We will be represented on a newly formed group from Baileys Harbor that is working to provide all of Northern Door County with Internet through the installation of Fiber Optic Cable. See January 6<sup>th</sup> article in the Pulse about this group.

#### Membership Work Group (Chuck Birringer – Acting Coordinator)

Our membership base which has remained constant over the past few years, has increased in 2021 in part due to the addition of the Associate Membership, additional members from the Southwest corner of the lake and New Construction around the lake. Paid memberships were up about 9% over 2020. However, there is still a lot of work to do since over 20% of our base that had not paid their dues in 2021. We are currently looking for someone to maintain the membership database for the Association. Visit our website under About Us/Committees to find out what is involved.

#### **Treasurer's Report (Chuck Birringer)**

In 2021 our total income of \$13,367.65 exceeded our total expenses of \$9,094.29 generating a net income of \$4,273.36. The 2021 actual income exceeded what we had budgeted by over \$4800 and the 2021 actual expenses came in below what was budgeted by over \$3200 leading to a net gain in income.
