First, please read the attached Frequently Asked Questions which should help you understand the project. At the request of the Technology Committee, Frontier has agreed to have several engineers/designers available at the Town Hall to meet with residents who believe they have unique location issues to get fiber to their homes or businesses. Frontier is planning to run the fiber to your home from the same pole where your telephone line comes from and in the same manner. If you have a house that fronts on a Town road (plowed by the Town) and you can see how your electric and telephone service runs from a pole to your house, you probably do not need to attend. The engineers will be present to discuss your *unique* property issues that may make getting service to your home a challenge. If you come, bring a map that you can leave with Frontier that addresses your issue.

At this time Frontier has conceptual plans to serve the Town and has just started with the detailed design for the new system. *The engineers WILL NOT be able to tell you when you will get service.*

You may want to attend if:

1. You never had telephone service to your home because you used cellular or satellite.
2. Your house is hundreds of feet away from the utility poles on the street.
3. Your existing electric and telephone service is buried and you want the fiber to run in a different route.
4. You are aware of rock or soil conditions that make boring or trenching a challenge.
5. You have multiple houses or cottages on your property which may not have telephone service, but now would want fiber service for each structure.
6. You receive electric or telephone service across a property you do not own.
