Need Chairperson – President is Point of Contact DNR still has not provided final report on the fish study in 2019 No request for Fishsticks or other Fish habitat requests

WQVC 2024 Annual Report/Plan

Major concerns How to reach people effectively. Lack of new volunteers and shrinking base with age, family and health issues. Continued development with increased upland run off risk and loss of natural shores. Noted almost 30 building or land clearing projects in 2022-2023 and already 3 or 4 new foundations this year.

to individual reporting.

Only one volunteer followed through on training. Will continue efforts to expand

various categories and scores.

Continue educational efforts at meetings, online and Facebook.

Table and brochures at summer kick off - one person took brochure and possible two interested in helping.

Clothing sale removed SOS focus and made CLAA support; added items and youth sizes. Will include pocket card with each delivery.

County Emerging contaminants report will be tracked along with the UW-O study

Tree sale not completed in 2024 due to health issues. Hope to resume or modify in

2025.

New DCIST coordinator but will attempt continued site visits.

Annual report of data monitoring for water quality and shoreland stewardship. Support of UW Oshkosh well water test and staff Jacksonport drop off site Support tree sale and promotion of the Big Plant event

Buffer Buddies site visits, individual projects and native plant sharing Publicize Invasive species identification and control options.

Map phragmites and facilitate county treatment of CLAA properties. At least one group invasive treatment day.

Ramp volunteers to assist boaters, promote CLAA and educate how to lessen boating footprint and preserve the lake.

Maintain Native plant and demonstration site at west ramp

Special events PFA surface water test to evaluate any possible fish contamination, Completed. Level okay. Mark in county wide emerging contaminants, includes PFA Update all lake bulrush map. Completed. Sponsor family/ children event to promote SOS. No action but did contact high school/middle school for volunteers and guidance counselor will help publicize Sponsor boat in July 4th boat parade promoting SOS. Done. Little opportunity to distribute pocket cards. Update and distribute Boating advice handout to renters and transient boaters. Handout done; delivered to properties that responded to letter (3) Subsidize Rain barrels as a water retention project to prevent runoff. Examples completed, at meetings. No takers. Explore expanding mandatory slow no wake area. Would require more data and action. All lake bulrush confirms further loss in area. Board requested informational buoy to mark 5-foot depth and voluntary Slow No Wake off south shore but not approved by DNR.

Lake Safety and Maintenance

DNR rejected buoy proposal marking Eco Zone for south end of lake. To complete this project, more buoys would be required, change in buoy category, and a Town ordinance may be required Dam – High water this spring has compromised the spillway fish guards and spillway portion of the dam. Working with DNR and Town Board Researching requirements for Dam inspection because of High water and dam

deterioration, Dam is 90 years old, last work done in 2009. Request sent to DNR and Sevastopol

Lake Management Plan not required because of work done by Paul Schumacher, Mark Weisse and other Committees. Dam items are outside of scope of Lake Management Plans

Investigating updated lake level mapping, last done in 1965
